

2026 KIDS FOOTY MONTH | MARVEL STADIUM SCVENGER HUNT

GAME OF SKILL TERMS AND CONDITIONS

SUMMARY

1. The Promoter of this competition is Melbourne Stadiums Limited (ABN 37 098 476 594), 140 Harbour Esplanade, Docklands, 3008, (03) 9643 1999. ("**Promoter**"). Any reference to AFL refers to the Australian Football League (ABN 97 489 912 318)
2. Any reference to Tradable Bits refers to Tradablebits Australia Pty Ltd (ABN 99 638 464 598).
3. This promotion is a contest of chance.
4. Information on how to enter and prizes form part of these Conditions of Entry. Participation in this competition is deemed acceptance of these Terms and Conditions.
5. The competition is governed exclusively by the laws of Australia.
6. The competition platform will be run on the Tradable Bits (**Platform**).

PARTICIPATION

7. Entry is open to all ordinary Australian persons who reside in Australia. Entrants under 18 years of age must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this competition.
8. Employees (and their immediate families) of the Promoter, participating outlets and the agencies associated with this promotion are ineligible to enter this competition. Immediate family means any of the following: spouse, ex-spouse child or step-child (whether natural or by adoption), parent, step-parent.
9. The Promoter reserves the right, at any time, to invalidate any entries (and entrants who submit or cause those entries to be submitted) which it reasonably suspects have been submitted:
 - (a) using false, incorrect, fraudulent or misleading information, including but not limited to personal details and contact information;
 - (b) through the use of multiple identities, email addresses or accounts; and/or
 - (c) in any way in contravention of these Terms and Conditions.
10. Incomplete, illegible or incorrect entries, or those which contain offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, will be deemed invalid.
11. If there is a dispute as to the identity of an Eligible Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Entrant.
12. Should an Eligible Entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter. A request to access or modify any information provided in an entry should be directed to the Promoter.
13. The Promoter reserves the right, at any time during, or after the closing date of the competition, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity and place of residence) and to disqualify any Eligible Entrant who submits an entry that is not in

DATE AND TIME

14. Competition commences on Saturday 27th June 2026 at 11:30AM AEST and closes on Sunday 19th July 2026 at 7:00PM AEST (the “**Competition Period**”).
15. To enter this competition, Eligible Entrants must during the Competition Period complete the Marvel Stadium Scavenger (**Hunt**) by collecting five (5) digital badges across Marvel Stadium during an AFL Match during the 2026 Kids Footy Month campaign, these games are as follows:
 - Round 16: Carlton v West Coast on Saturday 27 June 2026 commencing at 1:15pm (AEST);
 - Round 16: North Melbourne v Essendon on Sunday 28 June 2026 commencing at 3:15pm (AEST);
 - Round 17: Essendon v St Kilda on Sunday 5 July 2026 commencing at 3:15pm (AEST);
 - Round 18: Collingwood v North Melbourne on Friday 10 July 2026 commencing at 4:40pm (AEST);
 - Round 18: St Kilda v Port Adelaide on Saturday 11 July 2026 commencing at 1:15pm (AEST);
 - Round 18: Western Bulldogs v West Coast Eagles on Sunday 12 July 2026 commencing at 1:10pm (AEST);
 - Round 19: North Melbourne v Melbourne on Saturday 18 July 2026 commencing at 4:15pm (AEST); and
 - Round 19: Essendon v GWS Giants on Sunday 19 July 2026 commencing at 4:40pm (AEST).(collectively defined as **Match**)

The Eligible Entrant must be physically attending the Matches in Melbourne, Australia at the time to be able to enter and sign up to complete the Hunt via the Platform. A digital badge is collected via the Tradable Bits platform, once the Eligible Entrant completes the form, the Eligible Entrant must scan the corresponding QR codes at each destination and enter the required details.

16. Entries are deemed to be received at the time of receipt into the Promoter’s competition database and NOT at the time of completion by the Eligible Entrant. Any cost associated with entering the competition is the Eligible Entrant’s responsibility.

PRIZE

17. Participants that successfully complete Hunt will go into the draw to win the following:
 - One (1) x Major Prize (Major Prize):
 - Four (4) Category A Tickets to Harry Styles on Wednesday 2 December, 2026 at Marvel Stadium, valued at approximately \$1,020 (plus GST).

WINNER

 - The Match Day Prize will take place at AFL House, 140 Harbour Esplanade, 3008 on the Monday after the AFL Round is complete:
 - Round 16 (x Two (2) prizes in total) – Monday 29th June 12:00PM AEST
 - Round 17 (x One (1) prize in total) – Monday 6th July 12:00PM AEST
 - Round 18 (x Three (3) prizes in total) – Monday 13th July 12:00PM AEST
 - Round 19 (x Two (2) prizes in total) – Monday 20th July 12:00PM AEST
 - The Match Day Instant Spin Wheel will take place at Marvel Stadium during all eight AFL Matches during the campaign period from Gates Open to end of the Third Quarter.
27. The prize winner(s) will be notified via email within two (2) days of selection to organise the claiming of their prize. The Major Prize and Match Day Prize winner's name will be published on Marvel Stadium website from the day that the prize winners are selected.
28. The results of the draw are final and no correspondence will be entered into.
29. The Promoter reserves the right to request that the winners provide proof of identity prior to awarding the prize. Identification considered suitable for verification is at the discretion of the Promoter.
